Technical Corrigendum 1 to ISO/IEC 7816-6:2004 was prepared by Joint Technical Committee ISO/IEC JTC 1, *Information technology*, Subcommittee SC 17, *Cards and personal identification*.

*Page 1, Clause 1*

Add the following paragraph at the end of Clause 1:

“When an application uses an interindustry template, it is allowed to nest within this template tags of context specific class (see ISO/IEC 7816-4) unless previously marked as Reserved for Future Use by ISO/IEC JTC1/SC17.”

Page 2, Clause 4

In the first list, replace A, N, S and An with a, n, s and an, respectively.

In the second list, replace “n...3 means up to three binary-coded decimal digits;” with “n...3 means one, two or three binary-coded decimal digits;”.

Page 5, Subclause 6.8

In line 2, replace “It may also contain an authority indicator (see Table 11)” with “It may also contain an authority indicator (see ISO/IEC 7816-4)”.

Page 7, Clause 9

Insert the following rows alphabetically by Data Element in Table 6:

Page 10, Clause 9

In the row “Qualified name” of Table 6, delete “(defined in ISO/IEC 7816-4)” in column 2.

Page 12, Clause 10

Insert the following rows sequentially by tag number in Table 7:
