Page 11, 5.2.3


Add after the 2nd paragraph:

“For blunt extensions that are not an integral part of the cutting means, the following requirement shall be met.

The distance between the end of the cutting plane (3) between the cutting blades (2) and the side of the test cylinder (4) shall not be less than 4 mm when the test cylinder is positioned as shown in Figure 7 a) and then tilted around the ends of the blunt extensions (1) up to an angle of 40° as shown in Figure 7 b).”

Page 13, Figure 7

Add a new Figure 7 b) “Side view”, such that Figure 7 in ISO 10517:2009 becomes Figure 7 a) “Top view”.
