1 Scope

This part of ISO 15087 gives requirements, including dimensions, for Bein dental elevators.

2 Normative references

The following normative documents contain provisions which, through reference in this text, constitute provisions of this part of ISO 15087. For dated references, subsequent amendments to, or revisions of, any of these publications do not apply. However, parties to agreements based on this part of ISO 15087 are encouraged to investigate the possibility of applying the most recent editions of the normative documents indicated below. 3 Terms and definitions

For the purposes of this part of ISO 15087, the terms and definitions given in ISO 1942-3 apply.

4 Design and dimensions

4.1 General

4.1.1 Bein elevators shall conform to the general requirements given in ISO 15087-1.

4.1.2 Bein elevators shall be grouped into the following types according to the shape of the working end:

- Type 1 = Straight, small working end
- Type 2 = Straight, medium working end
- Type 3 = Straight, large working end

4.1.3 Bein elevators shall be designed in accordance with Figure 1, and with dimensions according to Table 1. Measurements of dimensions should be made as defined in Table 2.

NOTE Annex A of ISO 15087-1:1999 provides details of one method of measurement applicable to most types of dental hand instrument.

4.2 Length range

Bein elevators shall have an overall length in the range between 135 mm and 145 mm.

4.3 Handle

The design and dimensions of the Bein elevator handle shall be selected at the discretion of the manufacturer.

Table 2 — Points of measurement for Bein elevators

Symbol	Designation	Point of measurement
b_1	Blade width	Measured at a distance of 5 mm from the extreme tip of the instrument.
b_2	Blade thickness	Measured at a distance of 5 mm from the extreme tip of the instrument.
b_3	Blade length	Measured from the farthest extremity of the blade, parallel to the centreline of the blade, to the heel of the blade.
l_1	Working length	Measured from the farthest extremity of the blade, parallel to the centreline of the instrument, to the intersection with the handle.
r_1	Radius of blade	Radius of curvature of the inner surface of the blade.

5 Designation, labelling and marking

If the Bein elevator meets the requirements of this part of ISO 15087, then the manufacturer may include in the catalogue, on the package of the product and on the instrument the number of this part of ISO 15087 (ISO 15087-5) followed by an oblique stroke and the number indicating the type of elevator as shown in 4.1.2.

EXAMPLE A Bein elevator, type 1, in accordance with this part of ISO 15087 is labelled using the following format:
