Page 1, Clause 2, Normative references

Update ISO 188:1982 to “ISO 188:1998, *Rubber, vulcanized or thermoplastic — Accelerated ageing and heat resistance tests*”.

Delete ISO 471:1995 (replaced by ISO 23529 — see below).

Update ISO 1431-1:1989 to “ISO 1431-1:2004, *Rubber, vulcanized or thermoplastic — Resistance to ozone cracking — Part 1: Static and dynamic strain testing*”.

Replace “ISO 1817:1985” by “ISO 1817:2005”.

Update ISO 3865:1983 to “ISO 3865:2005, *Rubber, vulcanized or thermoplastic — Methods of test for staining in contact with organic material*”.

Update ISO 5893:1993 to “ISO 5893:2002, *Rubber and plastics test equipment — Tensile, flexural and compression types (constant rate of traverse) — Specification*”.

Above “NOTE 1”, insert the following new normative reference:

“ISO 7500-1:2004, *Metallic materials — Verification of static uniaxial testing machines — Part 1: Tension/compression testing machines — Verification and calibration of the force-measuring system*”.

After normative reference ISO 7500-1:2004, insert the following new normative reference:

“ISO 23529:2004, *Rubber — General procedures for preparing and conditioning test pieces for physical test methods*”.

Page 6, Table 4 — Test methods

Bottom row, column 3: Replace “ISO 3865:1983, method A2” by “ISO 3865:2005, method A, but exposing the test piece to light only”.

Bottom row, column 4: Replace “ISO 3865:1983, methods A2 and B” by “ISO 3865:2005, method A, but exposing the test piece to light only, and method B1, using distilled water as the test fluid”.

Page 7, Clause 6, Methods of test

Subclause 6.3, last line: Replace “(see ISO 471)” by “(see ISO 23529)”.

Page 10, Annex A

Clause A.1, paragraph 1, last sentence: Replace “to grade A of ISO 5893:1993” by “to class 0,5 or 1 of ISO 7500-1:2004 for force measurement”.

Page 16, Annex G

Clause G.3, line 2: Replace “(see ISO 471)” by “(see ISO 23529)”.
