- **end-date-and-time** contains the **end-date-and-time** stored in the **DFR-Search-Result-List-Content**;
- **ordering** contains the **ordering** stored in the **DFR-Search-Result-List-Content**;
- **search-domain** contains the **search-domain** stored in the **DFR-Search-Result-List-Content**;
- **search-criteria** contains the **search-criteria** stored in the **DFR-Search-Result-List Content**.”
