
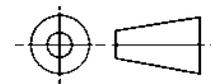


FIGURE 1 - REDUCER, ADAPTER, CONICAL END TO FLARED TUBE
